



Confirmation of Post-Secondary Education Primary Funding Source

In accordance with Gwich'in Tribal Council (GTC) Education and Training Policies, applicants who apply for student financial assistance to attend post-secondary programs, must have a primary funder in order to be eligible to receive educational bursaries from the GTC.

A primary funder can be a provincial or territorial organization or government who will provide a primary funding source in the form of grants, scholarships, and student loans. Applicant who is not in receipt of a primary funding source, must provide confirmation that they have sufficient funds to support their post-secondary expenses.
