## GTC BOARD OF DIRECTORS

GTC By-Law #1, Section 8.1: The board shall be the governing body of the Tribal Council between Annual General Assemblies and may establish general policies and set overall direction for the management and operation of the business and the activities of the Tribal Council. Members of the Board shall be entitled to such remuneration as may be determined by the Annual General Assembly by Special Resolution from time to time.

The Board shall be composed of the Executive and eight (8) Directors elected by the Members (Gwich'in Councils DGOs) of the Tribal Council. Two (2) of the Directors of the Board shall not be officers or employees of the Tribal Council or its Affiliates.
